Attention: Authorization Requirement Updates

Effective 02/01/2025, DHP **will not** require prior authorization for the following procedure codes within the benefit limit for in network providers only:

Laboratory Services

- 81515, detects bacterial vaginosis and vaginitis

COVID Testing

- 86318, qualitatively or semi quantitatively evaluate for antibodies to an unspecified infectious agent
- 99001, The provider prepares a specimen collected from a patient at a location other than the provider's office and sends it to an outside laboratory for analysis
- 86328, qualitatively or semi quantitatively evaluate for antibodies to the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) virus
- 86408-86409, screen for neutralizing antibodies against severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)
- 86413, quantify the level of antibodies to the SARS-CoV-2 virus
- 86769, evaluate for antibodies to severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)
- 87426, evaluate for antigens of severe acute respiratory syndrome coronavirus such as SARS-CoV-2
- 87428, qualitatively or semi quantitatively evaluate specimen for antigens of severe acute respiratory syndrome (SARS) coronavirus, as well as influenza A and B
- 87635, identify the nucleic acids from the severe acute respiratory syndrome coronavirus 2 (SARS-COV-2) virus
- 87636, detect and differentiate severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), influenza A, and influenza B
- 87637, detect and differentiate severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), influenza A, influenza B, and respiratory syncytial virus (RSV)
- 87811, analyze for the presence of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) (Coronavirus disease [COVID-19])
- 87913, genotype analysis using a specimen with confirmed severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) infection to identify virus mutations
- U0001, novel coronavirus (2019-ncov) real-time rt-pcr diagnostic panel
- U0002, sars-cov-2/2019-ncov (covid-19)

COVID-19 Convalescent Plasma

- C9507, Fresh frozen plasma, high titer COVID-19 convalescent, for use in the outpatient setting, in members with diagnosis U07.1

Lumbar Punctures

- 66270, diagnostic lumbar spinal puncture
