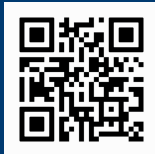


ADHD Workshop

Coverage Alert! Help Patients Renew their Benefits

Your patients' Medicaid coverage may have been impacted by the end of the COVID-19 Public Health Emergency. To make sure Medicaid patients are receiving important updates about their coverage, they need to visit YourTexasBenefits.com or call 2-1-1 to update their information.

You can help your patients by telling them to:

1. Look for a yellow envelope from Health Human Services Commission (HHSC) and respond by their due date
2. Update any household changes by logging into their account at YourTexasBenefits.com or through the mobile app
3. If they don't have an account, create one on the website, mobile app, or they can call 2-1-1 and choose option 2

How can you verify your patient's Medicaid coverage?

You can verify client eligibility for Medicaid through the Texas Medicaid & Healthcare Partnership's (TMHP) [TexMedConnect](https://www.texmedconnect.com) portal. You can also call 2-1-1, press option 2 then press 2 again to enter your National Provider Identifier (NPI).

2022 Performance Improvement Project: Improve HEDIS® Weight Assessment and Counseling for Nutrition and Physical Activity for Children/Adolescents (WCC)

Counseling for nutrition and physical activity as well as documentation of BMI percentile, may be captured during any outpatient visit. Outpatient visits include sick visits. These services count if the specified documentation is present, regardless of the primary intent of the visit. Accurate HEDIS documentation will decrease the need for medical record review.
