# **NEW Value-Added Service:** *Empowering Potty Time*

Driscoll Health Plan partners with Empower Behavioral Health to provide caregivers with potty training tips. Empowering Potty Time is a pilot potty-training program available at no cost to eligible Driscoll Health Plan STAR Kids members. Members under 20 years of age with autism and incontinence are eligible to join the program (restrictions and limitations may apply). The program uses proven strategies based on Applied Behavior Analysis (ABA) and includes a brief 30-minute online educational session, followed by a 3-to-4-hour one-on-one training session.

## Therapy Reevaluation Prior Authorization Removed

As of November 1, 2024, the first two reevaluations with in-network therapy providers occurring within a rolling 12month period do not require prior authorization. Additional re-evaluations completed during the same 12-month period or re-evaluations with out-oftherapy, physical therapy, and occupational therapy regardless of whether Driscoll Health Plan (DHP) is the secondary payor. If the primary insurance covers and approves the services, then DHP will pay any claims not covered by the primary plan. If the primary insurance denies the service or the member loses their primary coverage, then claims will be paid based on the DHP authorization already in place. Please submit all requests for therapy for prior authorization.

network therapy providers require prior authorization. If prior authorization is required, the requests for additional reevaluations must be faxed to DHP. The fax cover sheet should indicate that two re-evaluations have already been completed and prior authorization is needed.
