Value-Added Service (VAS): Empowering Potty Time

DHP in partnership with Empower Behavioral Health is introducing an ABA-based potty-training Value-Added Service called *Empowering Potty Time*. This VAS is available at no cost to members with neurodevelopmental conditions and functional incontinence.

Experienced technicians will work and guide caregivers through the program using positive reinforcement and personalized strategies to facilitate successful potty training. Additional benefits of this VAS include increased independence, improved self-esteem, and enhanced social skills.

DHP will have virtual sessions to kick-off *Empowering Potty Time* throughout 2025 to educate participants on the program. After attending the educational session, eligible members will be enrolled in the program. Incentives will be given to those who complete the educational session and the program.

To qualify, the child must:

- Be a Driscoll Health Plan STAR Kids member
- Be less than 21 years of age
- · Have a diagnosis of autism and incontinence
